On 9 April 2020, the Company announced that it had received binding commitments for a placement to professional and sophisticated investors to raise a total of \$1.0 million, before costs ("Placement").

The Placement will be completed in two tranches. Under the Placement, the Company will, subject to various shareholder approvals, issue a total of 26,350,000 fully paid ordinary shares at an issue price of 3.8 cents per share ("Share") plus 26,350,000 free attaching options ("Placement Options"), to raise a total of \$1,001,300, before costs.

On 17 April 2020, the Company issued 13,157,894 Shares at an issue price of 3.8 cents per Share, which raised \$500,000 before costs ("Tranche 1").
